Dear Mr. President:

We write to request your assistance in clarifying the U.S. government's knowledge of events in El Salvador from 1980 to 1991.

In a report published last week, the independent Commission on the Truth concluded that Salvadoran security forces, "death squads" with ties to the security forces, and FMLN rebels were responsible for thousands of civilian deaths during El Salvador's civil war.

Given this massive civilian toll and the extensive assistance granted by the United States to the Salvadoran government, we have an obligation to provide the most complete possible public accounting of what U.S. government officials knew, and when they knew, about the 32 human rights cases investigated by the Truth Commission. What the Truth Commission wrote about El Salvador applies equally well to the United States: "Bitter though the truth may prove to be in some cases, recognizing what happened in El Salvador is the first essential step to assuring that it will not happen again."

We commend Secretary of State Warren Christopher for his decision to appoint a distinguished panel to examine the State Department's activities during this period. We hope you will direct all national security agencies of the United States to cooperate fully with this important State Department initiative.

In addition to the State Department inquiry, we urge you to move immediately to secure, and then to review for declassification in an expedited fashion, all U.S. government documentary material relevant to the 32 human rights cases investigated by the Truth Commission. A list of these specific cases is attached.


In our view, the material reviewed for declassification should include, but not be limited to, diplomatic cables, embassy reporting, intelligence agency reporting, finished policy or intelligence memoranda, audio tapes, and computer records. We urge you to apply to this material a standard of review that will ensure the maximum possible disclosure, consistent with the protection of intelligence sources and methods. We also request the preparation of an index of all relevant material that is not ultimately declassified.

Our objective in making these requests is to bring into the open the facts about U.S. government knowledge of events in El Salvador, and to let the facts speak for themselves. Just as Salvadorans needed to know the truth about the crimes committed in their country to prevent their recurrence, Americans need to know what their government knew about these crimes to determine if mistakes were made and, if so, to ensure that they are not repeated.

We appreciate your consideration of our request and look forward to working with you.
