AS THE 1997 HUMAN RIGHTS REPORT NOTED, "DURING THE OPERATION, THE PARAMILITARIES SINGLED OUT AT LEAST SEVEN TOWNSPEOPLE AND EXECUTED THEM, REPORTEDLY FOR SUPPORTING THE FARC GUERRILLAS. SHORTLY AFTER THE EXECUTION OF THE NEXT MAJOR PARAMILITARY INCURSION IN THE GUAVIARE REGION: THAT THE OCTOBER 1997 INCURSION INTO THE SIMILARLY FARC-DOMINATED, COCA-CULTIVATING VILLAGE OF MIRAFLORES BY HIS OWN PARAMILITARIES HAD BEEN CONDUCTED WITH ARMY FOREKNOWLEDGE AND FACILITATION (REF F). THUS, IF PRIVATE STATEMENTS BY PARAMILITARIES INVOLVED IN THE ACTIONS ARE TO BELIEVED, IT APPEARS THAT THE TWO PARAMILITARY INCURSIONS INTO SOUTHERN COLOMBIA DURING 1997 WITH THE MOST DIRECT IMPLICATIONS FOR U.S.-ASSISTED COUNTER-NARCOTICS OPERATIONS IN SOUTHERN COLOMBIA -- JULY IN MAPIRIPAN AND OCTOBER IN MIRAFLORES -- WERE BOTH FACILITATED BY ELEMENTS OF THE COLOMBIAN ARMY. THE PROSECUTOR GENERAL'S OFFICE NOW GOES EVEN FURTHER, AND INCLUDES PUERTO ALVIRA AS ANOTHER SUCH INCURSION COORDINATED BY SOME OF THE SAME INDIVIDUALS IMPLICATED IN THE OTHER TWO INCIDENTS. ONE THING, AT LEAST, IS CLEAR: IT LIKELY WENT WELL BEYOND THE TWO ARMY SERGEANTS NOW STEWING IN ARMY DETENTION.
