THE MAP APPEARS TO BE A DOWNLOAD FROM:	ENTIFIED GE 61 1.4 c/d A PAGE VISTAN
BELOW IS A TRANSLATION OF THE TEXT: BEGIN TRANSLATION: LOCATION OF OSAMA BIN LADEN, MOUNTAINS OF PANJAB IN UNDERGROUND SHELTERS. HE HAS CONTACTS IN THE CITY OF AND KABUL. GROUND SUPPLY ROUTE IN THE CITY OF CHAGHC PROVISIONS AND ARMS FROM THE TALIBAN IN KABUL. HE HAS PERSONAL BODYGUARDS. THE PATHS AND ROADS (TO HIS LOC CONTAIN ANTI-PERSONNEL MINES. (SBU) ON 09/15/2001, THE EMBASSY DUTY OFFICER RECEIVED A CALL FROM AN U.S. CITIZEN NAMEL STATING 5TATING THAT HIS PASSPORT HAD BEEN LOST OR STOLEN BETWEEN THE MARGARITA ISLAND, VENEZUELA AIRPORT AND THE CARACAS AIRPORT. THE PERTINENT INFORMATION WAS PASSED TO THE CONSULAR SECTION, THE DEPARTMENT TASK FORCE, AND VENEZUELAN AUTHORITIES TO MAINTAIN A LOOKOUT FOR THE MISSING PASSPORT OR ANYONE USING IT.

5.
