WHAT WAS CALLED COLOMBIA'S FIRST AMAPOLA (HEROIN POPPY) MASSACRE. ONE OF COLOMBIA'S SMALLEST AND POOREST DEPARTMENTS, RURAL AND INDUSTRY-LESS CAUCA, WHERE LAND IS THE ONLY SOURCE OF WEALTH, IS HOME TO BOTH COLOMBIA'S LARGEST INDIGENOUS POPULATION AND ITS MOST INTRACTABLE LAND DISPUTES. IT WAS PRIMARILY TO WIN BACK LAND LOST TO LARGE LANDOWNERS THAT CAUCA'S INDIANS, WHO WIELD POWER OUT OF PROPORTION TO THEIR NUMBERS, FORMED THE REGIONAL INDIGENOUS COUNCIL OF CAUCA (CRIC) IN 1971. BY ALMOST ALL MEASURES, CRIC HAS SUCCEEDED, HAVING RECOUPED MORE THAN 80,000 CONFIDENTIAL

- 2 (U) CAUCA ALSO WAS HOME TO THE INDIGENOUS GUERRILLA GROUP, QUINTIN LAME, WHICH MADE PEACE IN 1991, AND NOW BELONGS TO THE AD/M-19 ON THE NATIONAL LEVEL. QUINTIN LAME EX-COMBATANTS, HOWEVER, HAVE HAD MORE SUCCESS THAN THEIR CAUCA M-19 COMRADES IN TURNING THEIR SWORDS INTO PLOWSHARES.
- 3. (C) WHILE CAUCA TRADITIONALLY HAS PRODUCED MARIJUANA AND COCA, THE NEW SCOURGE OF AMAPOLA, PRIMARILY PRODUCED BY INDIANS, NOW IS CONSIDERED ITS PRINCIPAL SECURITY THREAT. TO ITS SURPRISE, HOWEVER, THE GOVERNMENT HAS BEEN JOINED BY A WELCOME ALLY IN THE FIGHT AGAINST AMAPOLA, THE INDIANS' OWN LEADERS, WHO FEAR AMAPOLA WILL FINISH THE DESTRUCTION, BEGUN BY COLOMBUS, OF THEIR CULTURE. SINCE A MAY 1992 INDIGENOUS/GOVERNMENT ACCORD KNOWN AS "LA MINGA," INDIANS HAVE MANUALLY ERADICATED THOUSANDS OF HECTARES OF AMAPOLA WITHOUT VIOLENCE OR GLYPHOSATE. (U) FIRST AND FOREMOST OF CAUCA'S OTHER SECURITY CONCERNS IS THE GUERRILLAS, WHO BESIDES PLAYING A SIGNIFICANT ROLE IN POPPY PRODUCTION, ALSO ARE INVOLVED IN RANSOM KIDNAPPING, EXTORTION AND ROAD PIRACY. IN THE POLITICAL ARENA, CAUCA IS IN THE MIDST OF A TRANSFORMATION, AS CIVIC MOVEMENTS BEAT THE TWO CONFIDENTIAL

# CALOTO -- COLOMBIA'S FIRST AMAPOLA MASSACRE

6. (U) CAUCA ATTRACTED INTERNATIONAL ATTENTION IN DECEMBER 1991 WHEN 20 PAEZ INDIANS WERE MASSACRED BY A PARAMILITARY SQUAD IN CALOTO IN NORTHERN CAUCA. THE VICTIMS BELONGED TO A COMMUNITY OF SQUATTERS OCCUPYING A CORNER OF THE "EL NILO" ESTATE. AFTER YEARS PASSED WITHOUT RESOLUTION OF THE DISPUTE, THE OWNER APPARENTLY SOLD THE FARM (PROBABLY AT AN EXORBITANT PRICE THAT INCORA COULDN'T PAY) TO NARCOS APPARENTLY WANTING TO CULTIVATE AMAPOLA. AFTER THE INDIANS FAILED TO HEED SEVERAL WARNINGS, THE NARCOS, WITH THE AID OF LOCAL SECURITY FORCES (A POLICE MAJOR AND THE COMMANDER OF THE LOCAL POLICE ANTI-NARCOTICS UNIT FACE ADMINISTRATIVE BUT NO CRIMINAL CHARGES; REFTEL), USED VIOLENCE TO REMOVE THEM. A FEW MONTHS LATER, THE GOVERNMENT EXPROPRIATED AND DISTRIBUTED THE LAND TO THE VICTIMS' FAMILIES. VARIOUS PERSONS WITH WHOM POLOFF MET CITED CALOTO AS THEIR WORST FEARS COME TRUE OF WHAT COULD RESULT FROM A MIXING OF AMAPOLA AND CAUCA'S TRADITIONAL LAND CONFLICTS.

WHAT IS CAUCA?

7. (U) CAUCA DEPARTMENT IS LOCATED IN SOUTHWESTERN COLOMBIA, AT THE BIRTHPLACE OF FOUR OF THE COUNTRY'S MOST IMPORTANT RIVERS -- THE CAUCA, PATIA, CAQUETA AND MAGDALENA (COLOMBIA'S MISSISSIPPI) -- KNOWN AS THE CONFIDENTIAL

POPAYAN HAS LONG BEEN SUPERSEDED BY CALI (CAPITAL OF NEIGHBORING VALLE DEL CAUCA DEPARTMENT) AS SOUTHERN COLOMBIA'S PRINCIPAL CITY.

8. (U) CAUCA'S ECONOMIC STAGNATION HAS CAUSED IT TO FALL BEHIND MOST OF THE REST OF COLOMBIA IN SOCIO-ECONOMIC TERMS. FROM 1950-88, CAUCA'S ECONOMY FAILED TO DOUBLE WHILE THE COUNTRY'S MULTIPLED BY FIVE. WHILE COLOMBIA'S POPULATION GREW AN AVERAGE OF 3.4 PERCENT A YEAR DURING THE SAME PERIOD AND MADE THE TRANSITION FROM PREDOMINANTLY RURAL TO PREDOMINANTLY URBAN, CAUCA'S GREW ONLY 2.4 PRECENT A YEAR AND REMAINED RURAL. THE MAJORITY OF RESIDENTS IN 33 OF

THE CAUCA'S 37 COUNTIES (MUNICIPIOS) LIVE IN POVERTY.

- 9. (U) WEALTH IN CAUCA HAS ALWAYS BEEN IN THE LAND, BUT WHILE THE AGRICULTURAL SECTOR HAS MAINTAINED ITS PREMIER POSITION IN THE DEPARTMENT'S ECONOMY, IT CONTINUES TO BE BASICALLY LABOR-INTENSIVE, WITH A RELATIVELY LOW APPLICATION OF TECHNOLOGY, CAPITAL AND AGGREGATE VALUE. INDEED, CAUCA CONTINUES TO HAVE VERY LITTLE INDUSTRY, LIMITING EMPLOYMENT OPPORTUNITIES FOR ITS 800,000 RESIDENTS.
- 10. (U) WHAT HELPS DEFINE CAUCA IS ITS INDIGENOUS POPULATION, 130,000, THE LARGEST OF ANY COLOMBÍAN DEPARTMENT, COMPOSED OF SEVERAL TRIBES, INCLUDING PAECES (BY FAR THE LARGEST), GUAMBIANOS, YANACONAS, COCONUCOS, TOTOROS, EMBERAS AND INGAS. WHILE CAUCA HAS MORE BLACKS AND ALMOST AS MANY NON-INDIAN CAMPESINOS, ITS INDIGENOUS POPULATION HAS WIELDED POWER OUT OF PROPORTION TO ITS SIZE BECAUSE OF ITS CONFIDENTIAL

### CRIC AND THE NON-VIOLENT INDIGENOUS MOVEMENT

- 11. (U) IN 1971, CAUCA'S EMERGING INDIAN MOVEMENT GAVE BIRTH TO THE REGIONAL INDIGENOUS COUNCIL OF CAUCA (CRIC). AMONG THE ORGANIZATION'S OBJECTIVES WERE TO STRENGTHEN THE POSITION OF THE "CABILDOS" (INDIAN COMMUNITY GOVERNING COUNCILS), PRESERVE INDIGENOUS HISTORY, LANGUAGE AND CUSTOMS, AND END THE FEUDAL, SEMI-SERVILE "TERRAJE" SYSTEM, WHEREBY INDIANS PAID TERRATENIENTES (LARGE LANDOWNERS) RENT IN THE FORM OF LABOR TO LIVE ON AND FARM A PARCEL OF THE ESTATE. CRIC'S TOP PRIORITY, HOWEVER, WAS "TO RECUPERATE THE LANDS OF THE ORIGINAL RESGUARDOS (RESERVATIONS)," ACQUIRED FROM THE SPANIARDS BUT TAKEN BY TERRATENIENTES.
- 12. (C) AS CRIC MARKS ITS 22ND BIRTHDAY, IT CAN ONLY BE TERMED A SUCCESS, HAVING ACHIEVED ALL OF ITS OBJECTIVES, INCLUDING THE "RECUPERATION" OF MORE THAN 80,000 HECTARES. TODAY, CAUCA'S INDIANS LIVE IN 48 RESGUARDOS OCCUPYING A SIXTH OF CAUCA'S 29,000 SQUARE KILOMETERS. EVERYONE POLOFF SPOKE WITH SAID THE HISTORICAL TERRATENIENTE/INDIAN LAND CONFLICT WAS MOSTLY RESOLVED. REGIONAL INCORA (LAND REFORM AGENCY) HEAD GUERRERO TOLD POLOFF HIS STAFF RECENTLY HAD LISTED THE DEPARTMENT'S 10 TOUGHEST LAND DISPUTES; ONLY ONE WAS BETWEEN A TERRATENIENTE AND INDIANS. MEANWHILE, CRIC'S SUCCESS HAS SPAWNED COPYCAT REGIONAL INDIGENOUS COUNCILS IN OTHER DEPARTMENTS.

FROM THE START, CRIC HAS EMPLOYED A POLICY OF OCCUPYING PROPERTIES TO CREATE A CONFLICT INCORA WOULD BE FORCED TO DEFUSE. ONE CRIC REP SAID THAT EVERY TIME INCORA ANNOUNCES THAT IT HAS DISTRIBUTED "X" NUMBER OF HECTARES TO "X" NUMBER OF CAMPESINOS OR INDIANS, WHAT IT FAILS TO MENTION IS HOW MANY PEOPLE LOST THEIR LIVES TO GET INCORA TO ACT. WHEN POLOFF REPEATED CRIC'S CRITICISM TO INCORA CHIEF GUERRERO, HE RESPONDED, "COLOMBIA IS LIKE ANYWHERE ELSE IN THE WORLD; NO ONE GETS ANYTHING WITHOUT A STRUGGLE. "
- 14. (U) WHILE CRIC'S ORIGINAL OBJECTIVES HAVE MOSTLY BEEN MET, SOCIO-ECONOMIC INDICATORS FOR CAUCA'S

INDIANS LAG BEHIND THOSE FOR THE DEPARTMENT IN GENERAL. ONE OF CRIC'S PRESENT FOCUSES IS TO PROVIDE THE INDIGENOUS COMMUNITIES WITH NEEDED SOCIAL SERVICES, THUS FILLING THE VOID LEFT BY AN ABSENT GOVERNMENT.

15. (U) MEANWHILE, CAUCA'S INDIGENOUS MOVEMENT IS NOT WITHOUT ITS DIVISIONS. CRIC IS DOMINATED BY CAUCA'S (AND COLOMBIA'S) LARGEST TRIBE, THE PAECES. WHILE SOME GUAMBIANOS (CAUCA'S SECOND LARGEST TRIBE) LIVE ON PAEZ RESGUARDOS, AND THUS BELONG TO CRIC, MOST GUAMBIANO COMMUNITIES BELONG TO ANOTHER MOVEMENT, THE INDIGENOUS AUTHORITIES OF COLOMBIA. PAECES AND GUAMBIANOS HAVE OFTEN COMPETED FOR THE SAME LAND.

# QUINTIN LAME AND THE ARMED INDIAN MOVEMENT

THE RELATIVE INDIVIDUAL WEALTH OF COMMUNITY MEMBERS CULTIVATING AMAPOLA HAS GENERATED INDIVIDUALITY, MATERIALISM, NEGLECT OF FOOD CROPS, DISRESPECT FOR THE CABILDOS, AND VIOLENCE. CRIC,

AUTHORITIES BELIEVE THOSE CULTIVATIONS MUST BELONG TO

- 42. (U) MEANWHILE, INDIGENOUS LEADERS REPORT THREATS FROM GUERRILLAS OVER THEIR EFFORTS TO ERADICATE THE CULTIVATIONS IN THEIR COMMUNITIES. THEY ALSO COMPLAIN ABOUT GUERRILLA RECRUITMENT (FORCED AND OTHERWISE) OF THEIR COMMUNITIES' YOUTH. MEANWHILE, IN SOME LAND CONFLICTS BETWEEN INDIGENOUS AND TERRATENIENTES, THE GUERRILLAS ACTUALLY PROTECT THE TERRATENIENTE BECAUSE HE'S BEEN SUCH A GOOD AND COOPERATIVE PAYER OF EXTORTION.
- 43. (C) VARIOUS SOURCES, HOWEVER, TALKED OF HOW CAUCA'S GUERRILLAS APPEAR TO HAVE LOST INTEREST IN POLITICAL WORK, AND THUS HAVE LOST INFLUENCE AMONG THE PEOPLE. PNR CHIEF FERNANDEZ SAID THAT IT USED TO BE THAT WHEN A PNR PROGRAM OFFICER VISITED A RURAL COMMUNITY, SOME RESIDENTS WOULD RAISE POLITICAL/IDEOLOGICAL COMPLAINTS, AND AT TIMES ARMED CONFIDENTIAL

- 44. (U) CAUCA IS IN THE MIDST OF A POLITICAL TRANSITION. THE DEPARTMENT SHARES WITH THE REST OF COLOMBIA POLITICAL DOMINATION BY THE TWO TRADITIONAL PARTIES, THE LIBERALS AND CONSERVATIVES, WHO ALONG WITH THE CATHOLIC CHURCH HAVE SUPPORTED THE INTERESTS OF THE DEPARTMENT'S ELITE, THE TERRITENIENTES, WHILE ENGAGING IN A STYLE OF POLITICS CHARACTERIZED BY CLIENTALISM AND CORRUPTION.
- 45. (U) IN 1988, CIVIC MOVEMENTS COMPOSED OF INDIANS, CAMPESINOS, BLACKS, LEFTISTS AND OTHERS FORMED IN VARIOUS COUNTIES TO COMPETE IN COLOMBIA'S FIRST MAYORAL ELECTIONS. THEIR MODERATE SUCCESS WAS EXTENDED IN 1990, AND IN THE MARCH 1992 BALLOTING, CIVIC MOVEMENTS WON MOST OF THE DEPARTMENT'S MAYORAL RACES.
- 46. (U) CRIC, ASI, THE M-19, AS WELL AS THE PATRIOTIC UNION (UP; THE ELECTORAL FRONT OF THE COLOMBIAN COMMUNIST PARTY, THE POLITICAL SIBLING OF THE FARC GUERRILLAS) HAVE ALL PARTICIPATED. THE MIX IS DIFFERENT IN EACH COUNTY. THE BIGGEST MOVEMENT, MACIZO COLOMBIANO, HAS RUN CANDIDATES IN SEVERAL SOUTHERN CAUCA COUNTIES. ELSEWHERE, EACH COUNTY MAY HAVE ITS OWN MOVEMENT.

AURELIO IRAGORRI) WANT TO CONTINUE POLITICS AS USUAL, WHILE THE REFORMISTS (LED BY GOV. 49. (U) THANKS TO COLOMBIA'S NEW 1991 CONSTITUTION, CAUCA'S CHRONIC LAND CONFLICTS ARE ABOUT TO ENTER THE 21ST CENTURY, UNDER THE BANNER OF "TERRITORIALITY." TRANSITORY ARTICLES 329 AND 330 PROVIDE FOR "INDIGENOUS TERRITORIAL ENTITIES" (ETI), THE EXACT POWERS AND BOUNDARIES OF WHICH ARE STILL TO BE DETERMINED BY THE NATIONAL GOVERNMENT IN CONSULTATION WITH THE INTERESTS INVOLVED. WHAT IS CLEAR IS THAT ETIS WILL BE COMPOSED OF THE AREAS SURROUNDING EACH RESGUARDO. THE INDIAN COMMUNITIES WILL HAVE YET-TO-BE-DEFINED POWERS OVER THEIR SURROUNDING ETI, INCLUDING "TO COLLECT AND DISTRIBUTE FUNDS" AND "ENSURE ENFORCEMENT OF THE LEGAL RULES CONCERNING LAND USE AND SETTLEMENT."

DIRECTOR FERNANDEZ AND ANUC CAMPESINO ACTIVISTS TOLD POLOFF THE NEW INDIGENOUS TERRITORIALITY ALREADY HAS LED TO VIOLENCE BY CAMPESINOS FUNDED AND ARMED BY NARCOS CONCERNED ABOUT THEIR OWN PRIVATE PROPERTY RIGHTS.
